Procedure of account opening

Private Account-Standard/ Standard-Plus, Business Account-Standard

1. Payment of the account opening fee.
2. You will receive a confirmation by e-mail about your payment.
3. The account opening documents will be sent to you by the bank usually within 5-6 business days by post. From this point onwards you will be dealing directly with the bank.

Private Account-Premium, Bank Account for Asset Management, Numbered Account, Business Account-Premium

1. Payment of the account opening fee.
2. You will receive a confirmation by e-mail about your payment.
3. The exactly account opening instructions will be sent to you by the bank usually within 3-4 business days by email. From this point onwards you will be dealing directly with the bank.

General terms and conditions for the brokering of Swiss bank accounts

1. The customer authorizes GHS-Finance to brokering a Swiss bank account.
2. The GHS-Finance appears here only as a negotiator between the customer and the bank and is in no way liable for the conclusion of a contract, either directly or indirectly or for consequential damages of direct or indirect nature. The decision on the acceptance of the application lies solely with the Swiss bank and not with GHS-Finance.
3. The fee paid for the opening of an account is forfeited, if the customer cancels the order after placement of the order and cannot be reimbursed.
4. The fee paid for the opening of an account cannot be reimbursed, if the customer does not provide the documents or evidence requested by the bank and the opening of the account fails for this reason.
5. The fee paid for the opening of an account will be reimbursed, if the opening of a bank account is rejected purely for internal regulatory reasons by the bank, although the applicant had provided all the documents and evidence requested by the bank.
6. The customer agrees to receive information from GHS-Finance or its partners in cooperation through the communication channels mentioned (email, post, telephone) with the dispatch of the placement of the order. This consent is voluntary and will come into force immediately. It can be revoked in writing at any time. The passing on of the data to other third parties, in particular to commercial marketers, is ruled out.
7. A binding purchase contract is concluded with the signing and dispatch of the placement of an order. The payment is due with this purchase contract also. All payments are to be made without discounts.
8. The data entered in the application for opening an account will be forwarded to the corresponding bank for further processing after the payment of the fee for opening an account has been received and thus the contact between the customer and the bank will be established. With the forwarding of personal data, the client expressly agrees.
9. All agreements or commitments require the written form expressly and are binding only if sent by the executive management.
10. With the signing of the **placement of the order**, the applicant declares that they are legally taxed money, **which he** will deposit with the bank and the account is not used in any way to money laundering.
11. The applicant declares to have read and understood these general terms and conditions and they are considered as accepted and approved.
12. German law applies. The court of jurisdiction is Munich.

Notes on data protection: The protection of customer data is very important to us. All person-related data which is transmitted to us will be dealt strictly confidentially by us and will be stored only to process the application and forward it to the corresponding bank for the purpose of opening the account.
